Thomas Deacon Academy: Provider Access Policy 2018-2019

1. Introduction

1.1 This policy statement sets out the Academy's arrangements for managing the access of providers to pupils at the Academy for the purpose of giving them information about the providers' education or training offer. This complies with the schools' legal obligations under section 42B of the Education Act 1997 and the Technical and Further Education Act 2017.

2. Student entitlement

- 2.1 All students in years 7-13 are entitled:
 - To find out about technical education qualifications and apprenticeship opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
 - To hear from a range of local providers about opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events;
 - To understand how to make applications for the full range of academic and technical courses.
